### Catch and Release fishing sections

- All fish must be returned alive to the water
- The carrying and use of landing net is obligatory
- Authorised methods: artificial, single-hook lures, either barbless or with flattened barb
- Catch and release for river trout (*Salmo trutta fario*).
- Only brook trout (*Salvelinus fontinalis*) can be taken.

### Intensive fishing sections

- It is prohibited to take fish of less than 20 cm
- Authorized limit: 8 fish (4 per fishing section license)

### Valira Orient and Nord rivers

- It is prohibited to take fish of less than 30 cm
- Authorized limit: 8 fish

### Cercle dels Pessons

- It is prohibited to take fish of less than 23 cm
- Authorized limit: 4 fish

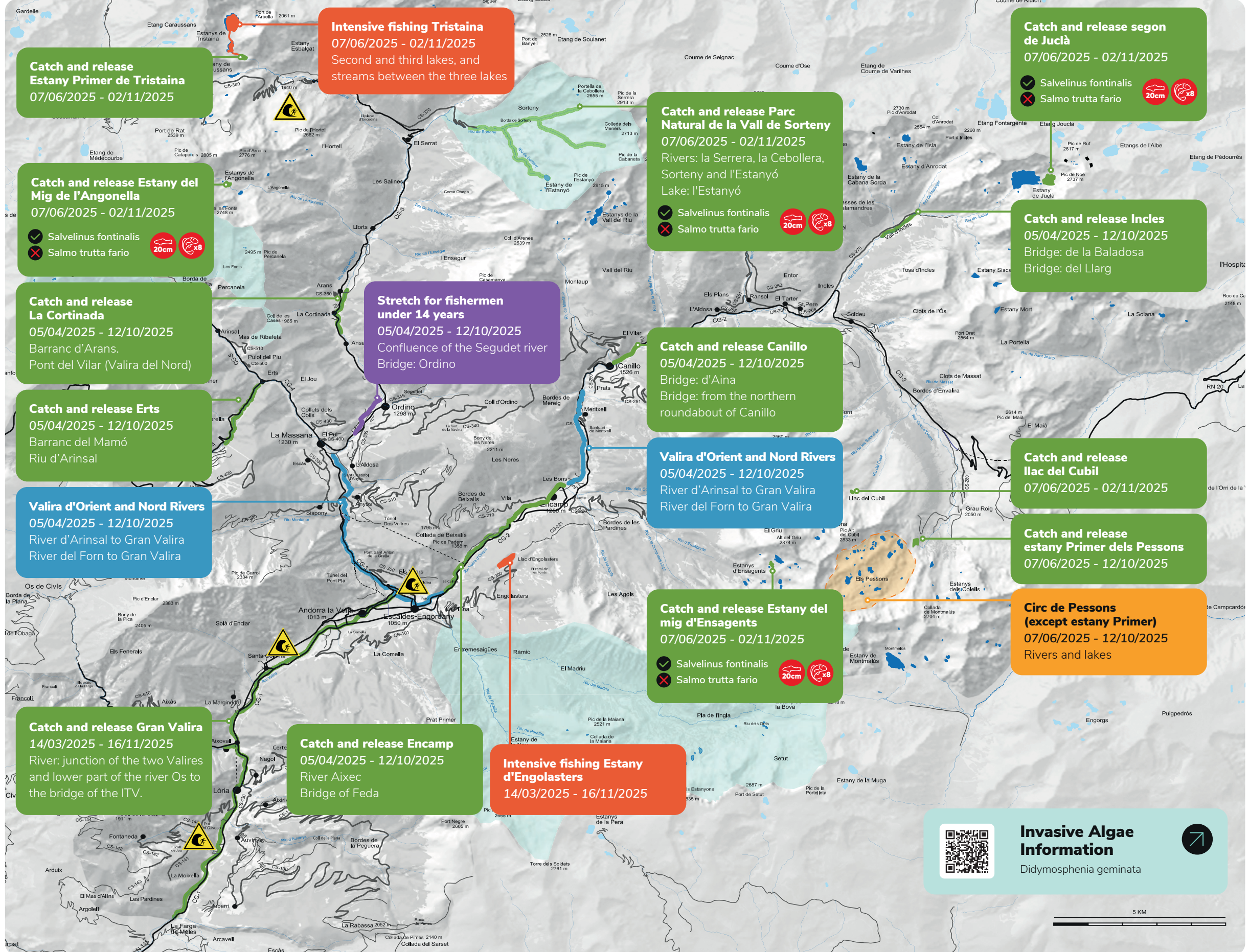
### Stretch for fishermen under 14 years

- It is prohibited to take fish of less than 20 cm
- Authorized limit: 2 fish

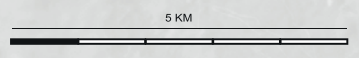
### Other areas

- It is prohibited to take fish of less than 20 cm
- Authorized limit: 8 fish
- The carrying and use of landing net is recommended

## Fishing practice

### The fishing permit

The seasonal fishing license consists of the "fisherman's card", personal and non-transferable, and the receipt for payment of the license for the current season. The wearing of both documents is mandatory for fishing.

Fishermen, resident or not, who have the M.I.L. (or electronic certificate) and the fisherman's card can renew the fishing permit for the season by paying by e-Procedures <https://www.e-tramits.ad>

If the fisherman does not have a MIL (or electronic certificate) he must pay the seasonal license directly to the processing services of the government or municipal administrative building.

The "fisherman's card" can be obtained from the processing services of the government or municipal administrative building. The application must be accompanied by a current colour identity picture of 3.5 x 4.5 cm and for non-resident foreign fishermen, a copy of an official identity document with the current address.

The renewal of the "fisherman's card" can be processed by email by sending the form <https://tramits.govern.ad/tramits/11T001.pdf> a [admin.pesca@govern.ad](mailto:admin.pesca@govern.ad), with the corresponding identity picture (scanned in colour).

### Fishing section licence

A fishing section licence is a personal and non transferrable document which must be held, along with the corresponding fishing licence, to fish in Andorra's fishing areas.

Only 2 fishing permits with catch can be obtained per day and fisherman.

### Catch and release

Catch and release must be done artificial lures with just one hook and the hook should be barbless or should have a flattened barb, and any fish caught must be returned to the water immediately. Any fish that are caught must be removed from the water using a landing net. Holders of catch and release licences should carry a landing net with them.

## Standards in force

Ministerial orders relating to the current fishing season.

**Fine: 30 € - 150 €**

- Fishing, transporting or being in possession of captured fish without holding the correct fishing documentation.

**Fine: 150,01 € - 300 €**

- Fishing, transporting or being in possession of fish or any aquatic organisme without having the correct fishing documentation.
- Exceeding the authorised capture limit (kept and/or transported) (+ €30 for each fish).
- Not releasing fish under regulation size (+ €60 for each fish).
- Fishing outside the legal hours. Fishing is only permitted during the day. This is understood to be the time between sunrise and sunset.
- Fishing with more than one rod at a time, or combining them.
- Fishing using banned bait, such as "maggot" bait, live or dead fish, fish eggs or cheese.
- Not releasing fish immediately when holding a catch and release licence.
- Releasing fish or other species (e.g. Phoxinus phoxinus,...) into the aquatic environment is banned.

**Fine: 300,01 € - 1.500 €**

- Out of season fishing. Fishing in fishing reserves. Fishing with boats or boating devices. Selling or buying fish that have been caught.
- Not releasing fish caught in catch and release areas.

**Fine: 1500,01 € - 3.000 €**

- Fishing once a licence has been revoked or after being refused a licence on administrative or legal grounds.
- Fishing using unauthorised methods.

In accordance with the Law, rangers who come across violations can confiscate fish and aquatic species that have been kept and also confiscate any devices or equipment used to commit the offence. If the offender is not a resident in the Principality of Andorra, any criminal report means that before leaving the country, the offender has to pay a deposit or guarantee equivalent to the maximum amount for the offence detailed in the criminal report.
